This modeling learning departs from the theory of Alber Bandura, he with one of the most important research is The Bobo Doll Studies. She filmed about one of the students who always ruined her bobo doll. The student always beat the doll, screaming and scolding. He kicked, took over, and kicked it with wood, while continuing to curse him. Bandura then show this film in front of the kindergarten students who of course really like the movie scene. After that kindergarten students are invited to play the game that is in the film. they play in a room complete with new bobo dolls, small clubs and the like. The result is that almost all children do what they watch in the movie.

Of course, observing others doing something does not necessarily result in learning, because learning through observation requires several factors or preconditions. Bandura finally established several stages of the process of modeling.

- a. Attention / attention process (attention). The influence of strong attention to the object is one of the modeling factors. This is what Bandura uses to explain the influence of television on children.
- b. Retention (memory) in the process of modeling stages of this memory has an important role. At this stage imagery and language begin to play. Memory stores whatever models are viewed in the form of mental images or verbal descriptions. When trsimpan, then this memory will be "recalled" image or description so that it can produce through behavior.
- c. Behavior production process (Impersonation of Model behavior). After careful observation and insert into memory, people then behave. Turning from a thought-picture into behavior raises the need for evaluation, "How to do it?" "What to do?" "Is that correct?". With regard to truth, learning

outcomes through observation are not judged on the resemblance of the responses to the imitated behavior, but rather to the learning objectives and efficacy of the learners.

d. Motivation. The modeling process will not work if the client or object has no self-motivation or motivation to imitate, in the sense that there is no reason for doing so.

Modeling Applications Albert Bandura

In general, the therapy Bandura uses is cognitive-social therapy. The goal is to improve self-regulation, by changing behavior and sustaining behavioral changes. Bandura proposes three different trajectory approaches, namely: mastering exercises (desensitization modeling), open modeling, symbolic modeling.

- a. Exercise (desensitization modeling): teaches the client to master the behavior that can not be done before by using the cognitive modeling model that the client is told to imagine what he wants to do such as, work harder, capable and dexterous to something without using real reinforcement.
- b. The client's open modeling (modeling of the participants) sees the real model, usually followed by the client participating in the model activity, aided by the model mimicking the desired activity, until it is finally able to do on its own without help.
- c. Symbolic Modeling: the client sees the model in the movie, or image or story. Vicarious satisfaction (seeing the model gets reinforced) encourages clients to try or imitate their model behavior.

Impact of Modeling Services

Each time a response is made, it will be followed by various consequences; there are the consequences of fun, some unpleasant, some do not enter awareness so that the impact is very small. Reinforcement - both positive and negative - the impact is not automatically aligned with the consequences of the response. The consequences of a response have three functions:

- a. Informers: informing about the impact of my behavior, this information can be stored to be used for guiding behavior in the future.
- b. Motivate future behavior: present data so that people can visualize the symbolic behavioral outcome they will be doing. In other words, behavior is determined or motivated by the future, where an understanding of what will happen in the future is derived from an understanding of the consequences of a behavior.
- c. Strengthening my behavior: success will be a reinforcement so behavior is likely to be repeated, otherwise failure will make my behavior less likely to be repeated
